## **SUMMARY OF SIGNIFICANT FINDINGS**

### **2010 PAROLE & PROBATION FORECAST – ACCURACY**

- Projections for the 2010 forecast were tracked from June 2010 to March 2011 (10 months). The active probation population was forecasted to an accuracy of +0.0 percent while inactive was forecasted to an accuracy of +0.5 percent. Active parole was forecasted to an accuracy of 1.1 percent and inactive parole to an accuracy of -0.3 percent.
- The active probation population was projected to decrease an average of 0.05 percent per month between June 2010 and March 2011. The actual population increased an average of 0.53 percent per month. The inactive probation population was projected to grow by an average of 0.11 percent per month but actually increased by an average of 0.13 percent.
- The active parole population was projected to grow an average of 0.2 percent per month between June 2010 and March 2011. The actual population increased an average of 0.12 percent per month. The inactive parole population was projected to grow by an average of 0.13 percent per month but actually increased by an average of 0.59 percent.

## **PROBATION TRENDS**

- Probation admissions decreased by 5.9 percent in 2010. This follows the trends for 2008 and 2009. Probationer intakes decreased by 7.2 percent between 2007 and 2008. In 2009 admissions to probation supervision decreased a further 5.0 percent. Since 2004, probation admissions have decreased by an average of 1.0 percent per year.
- Probationers in 2010 were sentenced to an average term of supervision of 46.6 months, up from 45.5 months in 2009.
- The number of active probationers (at year end) decreased by 3.1 percent between 2009 and 2010. This is the third consecutive year the active population has decreased.
- In Feb. 2011 the active probation population increased by 6.5 percent (or 1,290 cases). DCC reports that this was a one-time count correction and it is assumed the population will continue at this new established level.
- At year end 2010, drug court cases accounted for 7.2 percent of the active probation supervision case load.
- In 2010, for probationers ending supervision, the average length of stay (LOS) under community supervision was 33.3 months.
- Probation discharges averaged a LOS of 42.0 months while technical revocations and new felony revocations averaged a LOS of 19.9 and 20.7 months respectively.
- Revocations (new charge and technical together) to the ADC accounted for 18.0 percent (1,736 persons) of probation releases in 2010.

## **PAROLE TRENDS**

- Parole intakes decreased by 5.5 percent in 2010. A decrease in cases from the ADC accounted for a majority of the decrease.
- Parolees in 2008 were sentenced to an average term of supervision of 55.6 months, down slightly from 56.6 months in 2009.
- The active parole population remained static between year-end 2009 and year-end 2010. This in contrast to the one year growth between 2008 and 2009 when the number of active parolees increased by +9.8 percent.

- Parole technical revocations to the ADC accounted for 15.0 percent of parole releases in 2010 (or 1,314 cases)
  - 10.2 percent (836) of parole releases in 2009
  - 8.2 percent (683) of parole releases in 2008.
  - 5.3 percent (411 cases) of parole releases in 2007.
  - This number was 276 cases in 2006.
- Releases from parole supervision increased by 8.6 percent between 2009 and 2010. Technical revocations increased by 14.5 percent. New felony revocations increased by 14.1 percent.
- Technical parole violators were supervised an average of 14.0 months before being revoked while new felony violators had served 16.8 months.

## **DCC FACILITIES**

- Central CCC saw no growth in its average daily population (ADP) between 2005 and 2010.
- Northeast and Southeast CCC both saw an average annual increase in their ADP of 1.2 percent since 2005.
- Southwest CCC has seen a 4.7 percent average annual increase in its ADP since 2005.

## **PROJECTIONS**

- At the end of December 2010, the active probation population was 20,021. The population is projected to be 21,098 at year end 2011. By December 2021, the number of persons under active parole supervision is projected to be 23,955. The projected change represents average annual increases of 1.3 percent per year through the year 2021.
- At the end of December 2010, the inactive probation population was 10,041. The population is projected to be 10,434 at year end 2011. By December 2021, the number of persons under inactive parole supervision is projected to be 10,445 (w/o implementation of Act 570). With the implementation of Act 570, this number is projected to be 1,045 in 2021.
- At the end of December 2010, the active parole population was 13,799. The population is projected to increase to 14,576 in year end 2011. By December 2021, the number of persons under active parole supervision is projected to be 19,070. The projected change represents average annual increases of 2.7 percent per year through the year 2021.

- At the end of December 2010, the inactive parole population was 7,975. The population is projected to increase to 8,199 in 2011. By December 2021, the number of persons under inactive parole supervision is projected to be 10,911. The projected growth represents average annual increases of 2.9 percent per year through the year 2021. With Act-570 changes taking effect the inactive parole population is estimated to be 1,418 in 2021.
